Participant irrevocably waives all claims against the Fédération Internationale de Football Association (“**FIFA**”) and Major League Soccer, L.L.C., and each of their respective officers, directors, governors, employees, agents, successors, assigns, affiliates and subsidiaries (collectively, the “**FIFA Entities**”) and agrees that the FIFA Entities will have no liability or responsibility for any claim arising in connection with participation in this Sweepstakes or the prizes awarded. The FIFA Entities have not offered or sponsored this Sweepstakes in any way.
- 2. Sponsor’s clock is the official time keeping device for the Sweepstakes.

Western Avenue, Los Angeles, CA 90005 and electronically follow the on-screen instructions found on the electronic entry device to submit your official entry form as directed.

2) **Website Entry:** During the Sweepstakes Period, visit <https://www.hyundaievents.com/worldcup> and electronically follow the on-screen instructions to submit your official entry form as directed.

Entrants will be required to provide their complete name as it appears on his/her passport, zip code of residence, daytime telephone number including area code, a valid email address, primary language preference, and an acknowledgement that he/she is 21 years or older and understands and accepts these Official Rules and Sponsor’s privacy policy, and an answer to each of the questions presented (hereinafter, each an “**Entry**” and collectively “**Entries**”). **All Entries must be received by 11:59:59 PM PT on September 18, 2022. Limit one (1) Entry per person/per email address.** Any attempt by an entrant to obtain more than the stated number of Entries by using multiple/different identities names, addresses, numbers and/or any other methods will void that entrant’s Entry and that entrant may be disqualified from the Sweepstakes. Random Drawing will be conducted by Administrator whose decisions on all matters relating to this Sweepstakes are final. which will be final and binding in all matters relating to the Sweepstakes. Odds of winning will depend upon the number of eligible Entries received during the Sweepstakes Period. FIVE (5) PRIZES:** Each prize consists of an 8-day/6-night trip (includes two (2) travel days in flight between U.S. and Dubai, United Arab Emirates (“**Dubai**”)) departing on November 22, 2022 and returning on November 29, 2022 for one (1) person (winner only) to Dubai. Prize includes: one (1) General Admission Club ticket to each of the following FIFA World Cup Qatar 2022™ Matches: KOREA vs URUGUAY on November 24, 2022 at Education City Stadium in Al Rayyan, Qatar and KOREA vs GHANA on November 28, 2022 at Education City Stadium in Al Rayyan, Qatar; access to pre-match hospitality; round-trip economy class International air transportation for one (1) person (winner only) from a major U.S. gateway airport nearest the winner’s home to Dubai International Airport; transportation to/from Dubai International Airport and hotel in Dubai and scheduled activities, round-trip economy class air transportation between Dubai International Airport and Hamad International Airport in Doha, Qatar for both FIFA World Cup Qatar 2022™ Matches; hotel accommodations including certain meals designated by Sponsor (one (1) standard room, single occupancy); and sponsor-specified group tours in Doha City, Dubai and Abu Dhabi, subject to availability. The approximate retail value (“**ARV**”) of each prize is not to exceed \$8,000. **and Prevention, and/or the U.S. Department of Health & Human Services, as required, and having been vaccinated against COVID-19 (with an FDA or WHO-approved vaccine that has also been approved by the Dubai Health Authority and Qatar's Ministry of Public Health, if age-eligible).** Travelers may also be required to execute any assumption of risk and/or other documents relating to COVID-19 or he/she may not be permitted to travel or attend any scheduled activities.
